CONCLUSIONS

At March 2011, 89% of Sonning Common residents had been born in England; more than in wider areas.

The % of the mix represented by those born in Wales, Scotland and Northern Ireland were respectively 2.1%, 2.0% and 0.3%, collectively more than in wider areas.

The % of the mix coming from the Republic of Ireland was 0.7%, in line with wider areas.

The % of the mix coming from countries which joined the EU before March 2001 was 1.5%, slightly less than elsewhere.

(EU pre March2001 was 15 countries, The first 9 (France, Germany, Italy, Holland, Belgium, Luxembourg, Denmark, Rep. of Ireland and UK) plus Greece, Spain, Portugal, Austria, Finland and Sweden.)

The % of the mix coming from EU "Accession" countries (which joined the EU from April 2001 to March 2011) was 1.1%, again less less than elsewhere.

(Accession countries were: in 2004 (10 being Malta, Cyprus, 3 Baltic States, Czech, Slovakia, Slovenia, Hungary and Poland) and in 2007 (2, with 7 yr working restrictions, being Romania and Bulgaria). (Croatia joined in 2013 after the Census).

The % of the mix coming from other countries was 3.6%, which was very much less than in wider areas.
