CONCLUSIONS

At March 2011 in Sonning Common a currently lived Marriage/CP at 58.0% was the primary pattern and more so than in other areas Cohabiting at 8.7% was a lower part of the mix than elsewhere

Singles who have never married or registered a CP represented 18.5% of the mix - less than elsewhere.

Widows and surviving partners from marriages and CPs were rather ligher at 7.7% than elsewhere.
